Siblings will incur an additional agency fee of \$2500 PER CHILD for each country adopted at the same time through the same process, except Guinea, where the agency fee will increase by \$4500 PER CHILD. International fees for siblings vary based on country and will be charged based on each country or as otherwise specified above. Unrelated child adoptions are very rarely approved by ABI. In cases of unrelated children ALL Agency, Post Adoption Monitoring and International Fees will double, unless otherwise specified above. If you have questions about these fees it is your responsibility to ask ABI for clarification.

Pre-identified or relative cases will incur additional agency fees of \$2500-\$5000 per child dependent on country and situation in countries other than Haiti, which is \$5000 per pre-identified child.

Agency fees are for typical and normal adoption processes. They do not include assistance given for supplemental requests from USCIS or others involved in an adoption. These fees do not include assistance on Requests for Evidence, Notice of Intent to Deny or Denials. Assistance provided in those situations whether to the family directly or an attorney are billed at \$200 per hour in ¼ hour increments. Consultations beyond normal case processing are billed at the hourly rate.

ABI reserves the right at ABI's sole discretion to charge a monthly case management fee of \$200 for any case not completed 24 months from submission of dossier. This fee may be charged monthly until the case completes as defined by child receiving a visa to travel to the US.

Additional expenses may be incurred for additional supporting documents in country, such as a socio-economic report or in depth supplemental investigation if advised by ABI or required for USCIS approval. All expenses are the responsibility of the family.

Updates are required if a family does not receive a placement within the state mandated time frames. Addendums may be required for various life changes.

Home Study Only families that require consulting assistance, including assistance with requests for evidence or extensive supporting documentation will be billed the hourly rate of \$200 in ¼ hour increments. Advocacy efforts beyond a typical home study will be billed the hourly rate of \$140 in ¼ hour increments.

**Fees for domestic adoption with All Blessings International**

Program Application Fee - \$250

1st Agency Fee due with Match Acceptance - \$5,000 (non-refundable)

2nd Agency Fee due with Placement Acceptance - \$22,000 (refundable if an adoptive placement does not occur)

Birth Parent Counseling - \$500

Birth Parent Living Expenses – Varies, \$0-\$3,000 is average (unexpended fees are refundable)

Legal Fees for Termination of Parental Rights - Varies, \$1,000 - \$3,000 is average for an uncontested adoption (unexpended fees are refundable)

Adoption finalization is separate and charged at the discretion of the attorney you hire.

*\*Domestic fees are subject to change at the beginning of each year. Families receiving a domestic adoption through ABI will be expected to pay the fees current at the time of placement.*

## FINANCIAL AGREEMENT

All clients that sign into an agreement for adoption with ABI will adhere to the following guidelines regarding payments to ABI.

1. All accounts that are 30 days past due will be subject to 1 ½ % interest.
2. If for any reason your account has to go to a collection agency and/or attorney for collections you will be responsible for any and all fees accrued by the collections agency and/or attorney.
3. Any donation offered on behalf of an adoptive family shall be deposited into a humanitarian aid account or general agency expense account if an adoption process is formally stopped by or for the specified family. On rare occasions in the past a family has raised money specific for their adoption and portions of this are spent in fees, only to have the adoptive family decide to halt their adoption processing. This results in funds that are not clearly designated toward their original purpose; therefore, these shall be utilized for humanitarian aid or agency operating expenses. Please contact ABI for any needed clarification on the intent or meaning behind this policy.
4. All credit card payments will have a 4% fee added to process.
5. There will be a \$30 return check fee for all checks returned.
6. ABI reserves the right to revoke our status as a Primary Provider on an international case if fees are not remitted on time.
7. International telephone calls, faxes, shipping and other direct charges will be billed to the client family at cost.
