Our fee structure has thoughtfully combined the financial consideration of the families we serve and the needs of the agency to continue providing superior, ethical, professional, and compassionate child placing services in Tennessee, Kentucky and Indiana. Fees for various aspects of Pre-Adoption Preparation are combined and due in various points at the beginning of the process to off-set large sums due at once or small fees due sporadically.

ABI believes very strongly in preparing our adoptive parents for the challenges and joys of adoptive parenting through adoption education. As members of the adoption triad, we understand the life-long issues of adoption and believe this knowledge is imperative to impart to our clients for the long-term health of their families – a responsibility we take very seriously. All fees are charged at the current rates when services are provided. Fees may change while a family is in an adoption process.

Updates are required if a family does not receive a placement within the state mandated time frames. Addendums may be required for various life changes.

Advocacy efforts beyond a typical home study toward state foster adoptions and/or ICPC assistance will be billed the hourly rate of \$140 in ¼ hour increments.

Families with additional adult household members, previous criminal history, mental health concerns, medical history and other aspects that require additional consultations from ABI's clinical team or case workers will be charged for the additional time required to assess their case at the hourly rate of \$140 in ¼ hour increments. Families who have resided in multiple states and/or other countries will be charged additionally for the staff time to coordinate receipt of required child abuse checks.

Mileage is charged at .52 per mile with case worker total drive time beyond 2 hours will be charged at \$15 per hour. Mileage expenses are paid separately and directly to the case worker by the adoptive family. This payment may be done via check, PayPal or Venmo based on family and worker mutual decision. Extensive travel time will be invoiced to the family and paid through the agency for appropriate distribution.

Home study fees are due at the time stated in the above chart. 50% is refundable after the first visit should a family elect to withdraw. After second Interview, no home study fees are refundable.

*\*Domestic placement fees are subject to change at the beginning of each year. Families receiving a domestic adoption through ABI will be expected to pay the fees current at the time of placement. If a match agreement has been completed in the year preceding the child's birth/placement, fees will be due as contracted.*

## FINANCIAL AGREEMENT

All clients that sign into an agreement for adoption with ABI will adhere to the following guidelines regarding payments to ABI.

1. All accounts that are 30 days past due will be subject to 1 ½ % interest.
2. If for any reason your account has to go to a collection agency and/or attorney for collections, you will be responsible for any and all fees accrued by the collections agency and/or attorney.
3. There will be a \$50 return check fee for all checks returned.
4. Reports will not be sent if accounts are not current.
5. ABI reserves the right to revoke a positive home study if fees are not remitted in a timely way. Domestic and International shipping and other direct charges will be billed to the client family.
